

### AMENDED BY-LAWS

Members are requested to note the following By-Law amendments recommended by the Sub Committee on Rules & By-Laws and approved by the Executive Committee at its meeting held on 25<sup>th</sup> May 2016.

#### By-Law No.3 – Allocation of Tennis Courts

Morning: Courts 1, 2, 5 and 6 for Members  
Courts 3, 4, 7, 8 & 9 for Coaching  
Court 5 for Morning Members (7.30 AM to 9.00 AM)

Morning Members shall not be provided Club balls or ball boys.

Evening: Court 1 for Members (Court 2 also will be made available to members after 5.00 PM if there are more than 8 Members for Court 1)

Court 2 for Student Members (one of Courts 3 / 4 / 5 / 6 will be made available to Student Members if they have to make way for Members to use Court 2)

In case the clay courts 1 / 2 / 3 / 4 and hard courts 5 and 6 are not available due to rain or other reasons, courts 7 and 8 will be available for coaching and court 9 for Members.

#### By-Law No.4 – Members play

Members may choose to play either in the morning or evening or both.

**By-Law No.8 – Reservation of Tennis Courts**

- (i) The hours of reservation will be from 9.00 AM to 3.00 PM for Court Nos 5, 6, 7, 8 & 9 and from 7.00 PM to 10.00 PM for Court No.1, 7, 8 & 9 with lights.
- (ii) The reservation charges are Rs.200/- per hour for a maximum of 4 players if all players are members, or Rs.400/- per hour if any or all are guests. Lighting charges will be extra at applicable charges to be fixed by the Executive Committee from time to time.
- (iii) Reservation should be done in writing at least 24 hours in advance.
- (iv) Balls will not be provided by the Club for such reserved court usage.

**By-Law No.9 – Member’s usage of courts late evenings**

Members may use available courts after 6.30 PM (If there is no prior reservation) by paying the applicable lighting charges. Balls will not be provided by the Club.

**By-Law No.20 – Residential Rooms**

- (v) Not more than 4 rooms can be booked at any time by a Member. If the rooms are let out to participants of tennis tournaments an advance equivalent to 3 days’ rent shall be collected. The occupant shall pay for any damage caused in the room. Two rooms will be kept unreserved for occupation of members or Club guests who may require it at short notice, which will be allotted at the discretion of President and Hon. Secretary.

**By-Law No.23 – Tennis Coaching**

The normal hours of coaching will be from 6.30 AM to 10.30 AM & 3.30 PM to 7.30 PM.

**By-Law No.27 – Powers of Hon. Secretary**

**Clause f:**

The Hon. Secretary shall have the powers to initiate action against all categories of Members who violate the Rules & Regulations of the Club or behave in a manner causing difficulties to fellow members or disrupting the harmonious functioning of the Club. This shall include **show cause notices and suspension of facilities**, if it becomes necessary. Such actions are to be reported to the next Executive Committee convened for the purpose within 3 days from the date of suspension and the decision of the Executive Committee on the matter will be final.
